Completing the Application

- ✓ The Club membership year is July 1st to June 30th. Dues paid upfront for the full fiscal year 18-19 will grant you the remainder of FY 17-18 at no extra charge. A \$200.00 house credit will also be applied to your account. Initiation fees are due in full. Rates are subject to change.
- ✓ Both initiation fees and dues are subject to New York sales tax of 8.875%.
- ✓ ALL requested information must be filled out in order to process your application.
- ✓ All checks should be made payable to **The Penn Club** and to the attention to the Membership/Admissions Office. Credit card payment is accepted.
- ✓ Applications may be dropped off at the front desk, mailed, scanned & emailed or faxed to the attention of the Membership/Admissions Office at (212) 403-6616.
- ✓ Verification of the information on the application will be conducted during the membership acceptance process.
- ✓ Annual dues and initiation fees are determined upon thorough review of the information provided. Any additional charges that are determined by the membership department must be paid for in advance before the membership process can be completed.
- ✓ Please allow two weeks for processing of membership applications.
- ✓ Prospective members <u>may not</u> utilize the Club or any of its facilities or reciprocal clubs until notified of acceptance into the Club.
